

# TOW LAW TATTLER

## THERE WAS I DIGGING THIS HOLE !!!!!!!

Three meetings have so far been held with representations of Northumbrian Water, Durham County Highways, and McAlpines to try and find ways of minimising the Problems and the traffic chaos which have been caused by the renewal of water mains in the town. The good news is that from the contractors' point of view, work is progressing well, and it is hoped that an earlier finish than expected might be achieved, possibly around October.



Some positive results have been achieved by the meetings, in that traffic lights have been relocated from time to take account of the ongoing work, and indeed the lights have been removed completely from the A68 junctions with Smith Street and Ironworks Road.

At the latest meeting on Thursday 30<sup>th</sup> June, the highways representatives indicated that at peak times, around 30 vehicles can pass through the two phases of traffic lights each time, and while vehicles emerging from the Smith Street junction were to an extent dependent on the courtesy of other road users, the arrangements were operating satisfactorily.


It has been agreed that there is an urgent need for the re-instatement of the block paving at the bus stop in High Street, opposite the Co-Op, and this is now in hand. Similarly, reports of an oil spillage in the same area will receive urgent attention. The contractors have further agreed to arrange for the sweeping of the road at the rear of Bridge Street, following the completion of re-instatement work, and also in the Dan's Castle area, where accumulations of dirt are beginning to invade the drainage system.



The expectation is that work in the High Street will only be ongoing for two or three more weeks, while further work in the Castle Bank/Church Lane area will necessitate the retention of the traffic lights for perhaps three or four weeks. Work at the northern end of the town will necessitate the consent for a number of land owners, and this is currently being obtained.

It is emphasised that the current re-instatements using black

tarmac are only temporary, and that all work on areas which were previously coloured red will be completed in that colour.

At the Town Council meeting on 28th June, new Chairman Councillor Terry Batson, made a presentation to outgoing Chairman Jenny Flynn. The ceremony brought to a close Jenny's 14 year term in the Chair and members paid fulsome tribute to the many years commitment which she had given, both to the Council and the wider community.

The Chairman and Vice Chairman of the Town Council have been invited to a meeting with the Deputy Chief Executive (Environment & Change Management) Durham County Council, to discuss possible future regeneration projects in and around the town, following the many meetings which were held during the Foot and Mouth outbreak. The opportunity will be taken to push claims for some further investment into the community, which had more than its fair share of traumas at the time.

appointed our Link Worker. He will be working as part of the new team with responsibility for older young

people in the 12 – 20 age range and will take responsibility for working with other agencies on inclusion schemes. All will be taking up their post during the summer months so we hope to have more news from them in the next Tattler.


#### COURSE


