#### 080/07 Police Report

PC315 F. Hewison presented the Crime report figures for the month of May (copy attached to minutes) one main concern was bogus official preying on the elderly in the village but on this occasion they left empty handed. Also anti - social behaviour had dropped tremendously.

The Pcso R. Strong reported on 2 weekend patrols carried out in the village on Friday and Saturday evenings no anti- social behaviour at all. He seized 1 motor bike and 1 quad bike last month

Councillor R. Crogan asked the Police to keep watch down at the wow gym as resurfacing equipment was left bagged due to the weather also cctv would be left on all night.

### 082/07 Report of the County Councillor T. Carroll

Eco systems (boiler fuel) recycle wooden pallets. Councillor Carroll explain that you would only need to fill up once a day, it would have controlled drafts to hot it would switch off, huge potential. County hall have 2 in use and one on standby. Carbon neutral no charge when the new carbon tax comes in. Delivery would not be a problem. Scrap pallets costs £80 per ton compared to coal which is £140 per ton. There is going to be 4 new schools built using this system. Councillor P. Graham said you couldn't grow enough wood in the country. This would be left to a people choose.

T. Carroll left the meeting j 7 o'clock.

He talked about the problem of not having a dog bin in Alpine way he also talked about a play area for the local children. Bayonet on the monument to be replaced again a lengthily discussion took place i.e. the cost, weather as we know it can get extremely windy at the monument, Councillor J. Day did not know nothing about this and Mary bell who are the interested party, Councillor A. Blacker suggested the above item be done for him to get intouch with Heritage lottery, monument society, fundraising Councillor P. Graham supported the idea. They were no objections needs permission of Mary Bell and J. Day as long as the above work together and it is done properly.

### Councillor Ron Grogan reported

Resurfacing progress, CCTV in operation at the wow gym, Barclay bank Mr Cudderford to get back to him. If Ron was to get compulsive purchase order on the bank it would take 18 months and cost £1000.00. Ron spoke about Geoff Smith Clerk to the council was still in hospital and that the acting Clerk John Abbot went early as he wasn't feeling unwell. P. Graham had called into to see John he was really upset. Ron read out John letter copy of which is attached. Ron said he would ring Mr Steve Ragg at DALC for advice on situation regarding the correct Town Council Procedure for the Town Clerks situation.
