Members also agreed to accept the Statement of Account as at 31^{st} December 2009 (Balance £18,546.61).Members further agreed to set the Precept for 2010/11 at £22,429.00. This was 10% increase (£2039.00) on the 2009/10 figure (£20390.00), The tax base for 2010/11was 583.2 compared to 573.0 for 2009/10. The band D tax for 2010/11 would be £38.45, which is an increase of £2.87 which equates to a 8.21% increase on the 2009/10 figures.
