# AGM 15/10 Power of Well Being

To use the Power of Well Being (The Local Government and Public involvement in Health Act 2007 section 77) The Town Council must fulfil the following conditions (Parish Councils (Power to promote Well Being) (Prescribed conditions) order 2008 (the prescribed condition Order):-

A) Minimum of two thirds of vacancies to be filled at the last Ordinary Election

- B) Qualified Clerk trained in the Power
- C) Minimum of 80% of Councillors trained in the Power

D) Published Statement of Community Engagement

As the Town Council meets all of the above criteria they wish to use the Power of Well Being from the date of this meeting. The Power will be used to improve the Economic, social and environmental, well being of the area and will also have regard to the Durham County Council's Sustainable Community Strategy for County Durham (2010 – 2030) and relevant government guidance.

The period of eligibility will last until the day before the next Annual meeting held in the year of Ordinary Elections (2013).

Members also **agreed** to arrange for some publicity to advertise what the Town Council have achieved.
