# **173/13** Minutes of a the Ordinary meeting held on 15<sup>th</sup> October 2013 The minutes were agreed as a true record and signed by the Chairman.

#### 174/13 Matters arising

Councillor Rowland on the quotation received from Proludic Ltd for play equipment at Attlee Estate at a cost of £24695.00. Work is ongoing to obtain funding for all the projects. Detailed drawings are available to view in the Clerk's office.

The Clerk updated Members on a meeting held with the Chief Constable on 7<sup>th</sup> November 2013 to consider possible site/s for pedestrian crossings (light controlled) in High Street. The meeting was attended by Councillors Gale, Rowland, Green and Hird. Feedback was very positive and a further meeting with County Council Highways staff and traffic department of the Police would be arranged in the near future. The Clerk suggested further ways of improving the bid (i.e. residents petition, suggested crossing area etc). The Clerk also updated Members that he had ordered 60 x 4ft Christmas Trees @ £15 each, 1 no 5.5 mtr Christmas Tree @ £150 and 3 boxes of solar fairy lights @ £150, delivery is expected in week commencing 25<sup>th</sup> November 2013. The Clerk took names of Councillors who volunteered to help "dress" the tree.

Councillor Stokes again raised the issue that the temporary mast at High West Farm was still in place. Clerk to remind DCC Enforcement Officer.

#### 175/13 Police Report

**b)** Tow Law Millennium Primary School

**d)**Tow Law Community Association (The Cubs Organisation) Members agreed to donate £250 from the N-power Community Fund to support the start up of the Cubs organisation which meet in the Community

Centre, Tow Law.

2) Update on Quality Council Scheme

New minimum evidence required for a Council to obtain either one, two or three star Quality Status. This scheme is to be implemented in early 2014. The Town Council remains a Quality Town Council until the scheme is open for submission.

## 186/13 Members Reports

#### Christmas Theme 2013 (Councillor Green)
